

## COMPETITION REGULATIONS

Polish Radio External Service in DAB+ digital quality

organised by

Polskie Radio S.A. (hereafter referred to as "The Organiser") with its seat at Al. Niepodległości 77/85, 00-977 Warsaw, written into the Legal Register of Companies under no. KRS 0000017753, NIP tax identification no. 521-04-14-265, with a nominal capital of PLN 8,366,300, paid in full.

The aim of the Competition undertaken by Polish Radio External Service is to increase the popularity of the station.

### § 1

#### GENERAL RESOLUTIONS

1. The Competition is aimed at listeners of the English Section of Polish Radio External Service and will be published on the English Section's webpage at [thenews.pl](http://thenews.pl) on 3 February 2014.
2. The Competition is only open to adult individuals with full legal capacity who fulfil the conditions of the regulations listed herein.
3. The Competition Participant is an individual who submits their entry (hereafter referred to as "The Work") by email to [thenews@polskieradio.pl](mailto:thenews@polskieradio.pl) or by regular post to **Polskie Radio dla Zagranicy English Section, Al. Niepodległości 77/85, 00-977 Warszawa**.
4. Employees and co-workers of Polskie Radio S.A., members of their families and other dependants are not able to take part in the Competition.
5. Competition Participants are obliged to give their name, surname, postal address and email address.
6. Every Competition winner may win only once.
7. Submission of entry by the Participant, either electronically or by post, simultaneously denotes acceptance of the regulations and allows for the public disclosure of the Participant's name, surname, and town of residence on the pages of Polskie Radio S.A. and on air.

### § 2

#### COMPETITION PRINCIPLES AND DURATION

1. The Competition's task will be hosted on [thenews.pl](http://thenews.pl). Listeners are asked to send in their submissions in accordance with the question published on the relevant internet page on [thenews.pl](http://thenews.pl).
2. Submission of entry by the Participant simultaneously denotes the wish to take part in the Competition and acceptance of the regulations
3. Every Participant is permitted to take part in the Competition by submitting any amount of entries, with the caveat of § 1 article 6.
4. The Competition envisages one main prize with three runner-up prizes.
5. Submissions are accepted from the moment the Competition is published on [thenews.pl](http://thenews.pl), from 3 February 2014 until 23.59 CET on 16 February 2014.
6. The submitted Work:
  - a) must be the individual work of the Participant;
  - b) must not include offensive language or break Polish law;
  - c) must not be the work of third parties, including the use of personal property, copyrighted material or related rights.
8. The Competition winner is the Participant whose text (submitted in accordance with the Competition's task) is judged the winner by the Organiser's Jury. The Jury will take originality, ingenuity, and the artistic value of the text into account.
9. The names and surnames of the winner and runners-up (including towns of residence) will be announced on [thenews.pl](http://thenews.pl).

### § 3

## **PRIZES**

1. The prize awarded for first place is a leather wallet with an embossed logo of Polish Radio External Service. The runner-up prize for Participants gaining second to fourth place is an 8GB pen drive.
2. The prizes are non-transferable for other items or for cash.
3. The winners will let the Organiser know of the exact details needed in order to expedite the relevant prizes within 30 days of the winning announcement.
4. The prizes are exempt from taxation in Poland.

## **§ 4**

### **PERSONAL DATA**

1. The administrator of the submitted personal data needed to process the Competition is the Organiser.
2. Personal data handed over to the Organiser by Competition Participants are kept by the Organiser solely for the purpose of the Competition and prize mailings. Handing over your personal data is voluntary, although it will prohibit the Organiser from sending out Competition prizes. Every Participant has the right to inspect, amend or withdraw their personal data. Personal data is processed in accordance with the law dated 29 August 1997 on personal data protection (Law Gazette from 2002, No. 101, position 926 with amendments thereafter), to which Participants agree.

## **§ 5**

### **COPYRIGHT**

1. Every Participant agrees that the Work submitted to the Competition is created individually by the Participant and is free from rights or claims from third parties, including copyrights and related rights, and that the Participant takes full responsibility in this respect, absolving the Organiser from any claims from third parties that may arise.
2. The Participant agrees to hand over all rights (including copyright, property rights, territorial rights) at the moment which the Work is submitted to the Competition for an unlimited period for the following use:
  - a) recording and multiplication (including computer memory) of the Work in any possible medium;
  - b) making the Work publicly available in such a manner that it is possible to access at a time and place chosen by the Participant,
  - c) broadcasting the Work in the form of sound.
3. The Participant allows the Organiser to distribute the Work anonymously.

## **§ 6**

### **COMPLAINTS**

1. All complaints should be addressed to the Organiser's Complaints Commission at Polskie Radio dla Zagranicy 00-977 Warszawa, Al. Niepodległości 77/85.
2. All complaints will be reviewed within 14 days of reception by the Complaints Commission. The Participant will be informed of the proceedings in writing.

## **§ 7**

### **FINAL RESOLUTIONS**

1. The Competition is conducted on the basis of these Regulations is not a game of chance, lottery, bet, or a promotional lottery, whose results are understood on the basis on article 2 of the law dated 19 November 2009 on betting games (Law Gazette from 2009 No. 201, position 1540 with amendments thereafter).
